We, the customer acknowledge:

- No agency, partnership, joint venture or any other type of similar relationship exists between ANZ and Class Technology;
- Neither ANZ or Class Technology will, subject to any prohibition or limitation imposed by law, be liable for delays, non performance, failure to perform, processing errors or any other matter arising out of this agreement;
- This agreement is to be read together with the ANZ relevant terms and conditions that govern the Accounts, however, to the extent of any inconsistency these terms will prevail;
- ANZ will not be liable to any person for their reliance on any Data supplied to Class Technology or any failure of ANZ to provide information or to provide complete or accurate Data to Class Technology;
- ANZ may decide at its sole discretion, on any ground it thinks fit and, without rendering ANZ or Class Technology liable in any way, to discontinue the provision of Data to Class Technology pursuant to this authority by written notice to Class Technology;
- We may terminate this agreement on providing 5 business days written notice to ANZ.
- Data Feed Authorisation**

For the purposes of this Data Feed Authorisation Form:

'Account' means the account that is being referred to under this form and being linked to Class Technology Pty Ltd who is the Data Feed Recipient nominated in this form.

'Data Feed' means the provision of the Customer Data via the Data Feed Recipient/s's platform or interface or any other means ANZ reasonably considers appropriate to share the Customer Data with the Data Feed Recipient/s.

'Customer' means the Account holder/s or anyone authorised to operate the Account by the Account holder/s.

'Customer Data' means all data, material, records and information including transaction data, account balance, account statements and other financial information (whether or not personal information or confidential information) which is made available to ANZ in relation to the Customer and/or the Account.

'Data Feed Recipient' means Class Technology Pty Ltd.

The Customer acknowledges and agrees that the Customer has requested ANZ to link the Account to the Data Feed Recipient/s and for ANZ to conduct the Data Feed subject to the terms set out in this clause.

The Customer acknowledges and agrees that:

- ANZ will from time to time provide the Customer Data via Data Feeds to the Data Feed Recipient/s;
- the Customer Data will be disclosed to the Data Feed Recipient/s;
- once the Customer Data is provided to the Data Feed Recipient/s, the Customer Data is subject to the information security controls of the Data Feed Recipient/s;
- ANZ is not responsible for any damage, loss or cost arising from any information included in the Data Feeds except to the extent that the damage, loss or cost arises from negligence, fraud or willful misconduct by ANZ, its officers, employees, contractors, agents or any receiver appointed by ANZ;
- the effective activation of the Data Feed will be determined by the Data Feed Recipient/s; and
- once the Data Feeds have been activated, this agreement will stand between the Customer and ANZ until the Data Feed/s are deactivated.

The Customer authorises ANZ to:

- provide the Data Feed Recipient/s, access to Customer Data including any personal information or financial information that relates to the form or the Account (including copies of documents issued in relation to the Account). This is in addition to the powers that the Data Feed Recipient/s may have as an authorised operator on the Account;
- if the Data Feed Recipient/s is a company or partnership, the Customer authorises ANZ to provide such information to any officer, employee or partner of the company or partnership. If the Account is to be held in a trust, details of the trustee and beneficiaries of the trust have been submitted with this form; and
- disclose Customer Data including current and historical transactional details, including account balances and account statements in relation to the Account to the Data Feed Recipient/s to be made available to the Customer's authorised ANZ intermediary/adviser (where applicable).

The Customer understands and accepts that:

- ANZ may charge fees to the Data Feed Recipient/s for the Data Feed service;
- the Data Feeds, once activated, can be deactivated by any signatory on the Account (or their delegates) regardless of whether they were involved in setting up the Data Feeds; and
- while ANZ will make a reasonable effort to provide historical data (if requested), historical data is subject to compatibility between the Account and the Data Feed Recipient's software platform or interface on which the Data Feed is provided.

The Customer consents, including on behalf of any account signatories on the Account, and understands they will be able to view and access the transaction data and account balance and account statements sent to the Data Feed Recipient/s, regardless of who sets up the Data Feed.

The Data Feed Recipient/s may deactivate the Data Feed without the Customer's consent, and the Customer accepts this is outside of ANZ's control.

ANZ may, without the Customer's agreement, make the following changes to these terms at any time by giving the Customer at least thirty (30) days' written notice:

- changes to comply with any law or any change in law, or any decision, recommendation, regulatory guidance or standard of any court, tribunal, ombudsman service, regulator, or any other similar body; and
- changes that are administrative or correct a mistake, inconsistency or omission.

This authority is only valid from the date it is signed by the authorised signatories to the Accounts.
